





Kansas' Tax Changes


2012-2013

- Revenue Reductions
 - Income Tax Rate Cuts
 - 333k Small Biz Exemption
- "Pay Fors"
 - Sales Tax Increase (6.15%)
 - Elimination of Credits

2015

- Revenue Reductions
 - Future Income Tax Rate Cuts
 - Future Low-income exemption
 - 333k Small Biz Exemption
- "Pay Fors"
 - Sales Tax Increase, <u>again</u> (6.50%)
 - Cigarette Tax Increase
 - Elimination of Itemized Deductions

WHAT ABOUT KANCARE?

KanCare

 2013 - Three private Managed Care Organizations (MCOs) handle most of the 385,000 Kansans in Medicaid and CHIP

 In first two years of KanCare, the three MCOs have had a net loss of almost \$170 million



Workplaces with the most uninsured workers who could gain Medicaid coverage in 2014"




